

PATRON RESPONSIBILITIES AND CONDUCT

The Massanutten Regional Library is supported by taxes of the people of Rockingham County, Page County, and the City of Harrisonburg, and the Commonwealth of Virginia. The people expect each of our facilities to be a clean, comfortable, and safe place for reading, research, study, meetings, and leisure. Everyone has an equal right to access library services and facilities; no person has the right to interfere with the ability of others to use and enjoy these resources, facilities, and services.

To this end, MRL has established rules and guidelines of conduct to protect the rights, comfort and safety of Library patrons, volunteers, and staff, and to preserve and protect the Library's materials, equipment, facilities, and grounds. The following list includes, but is not limited to, examples of conduct not allowed on Library property:

- 1. Any activity in violation of federal, state or local law, or Library policy
- 2. Carrying firearms and dangerous weapons, unless in accordance with state law (Virginia Code 18.2-308)
- 3. Being under the influence of alcohol/illegal drugs or selling, using, or possession of alcohol/illegal drugs
- 4. Verbally or physically threatening or harassing other patrons, volunteers, or staff, including running, fighting, stalking, staring, touching, using offensive and/or boisterous language and engaging in lewd or indecent behavior
- 5. Stealing, damaging, altering, or inappropriate use of Library property in Library facilities or on Library grounds
- 6. Trespassing in non-public areas, or presence in the Library without permission of an authorized Library employee before or after Library operating hours
- 7. Using cell phones, pagers or other audio devices in a manner that disturbs other visitors. Cell phone and pager audible ringers must be turned off in the Library
- 8. Soliciting or conducting surveys not authorized by the Library
- 9. Using restrooms for bathing or shampooing, doing laundry
- 10. Using tobacco or nicotine products in any form, including electronic cigarettes or vaping devices
- 11. Lying down or sleeping on any floor, table or seat in the Library

- 12. Consuming food in public areas of the Library, including restrooms, unless authorized by the Library Director or Branch Manager or for special library events
- 13. Bringing pets or animals, other than service animals for disabilities, into the Library, except as authorized by the Library Director or Branch Manager
- 14. Entering the Library barefooted, without a shirt, with offensive body odor or personal hygiene so as to be disruptive to the Library environment
- 15. All bags and other articles are subject to inspection by authorized Library personnel. The Library reserves the right to limit the size and number of items brought into the Library
- 16. Personal photography and videography is only permitted in the Library when it does not disrupt operations or invade the privacy of patrons, including patrons' reading, research, browsing activity, and/or computer usage
- 17. Any behavior that disrupts or hinders public use of the Library is prohibited

Library staff members have the authority to intervene to stop prohibited activities and behaviors. Failure to comply with the Library's established standards of acceptable behavior may result in one's removal from the building and/or restriction of Library privileges.
